Art35^oNorth is a is an organization dedicated to supporting the visual arts in the region of latitude 35^o North and promoting Collaboration, Conversation, Community and Creativity among artists, art supporters, art collectors and the communities of this region. ART35N encourages involvement by artists in all types of media and by non-artists seeking to support local art. Members of ART35N are eligible to participate in workshops, classes, critiques, and other related programs.

Membership Categories

Exhibiting Members of ART35N have been juried into this membership category. This is a lifetime designation subject to the \$50 annual dues. Membership is open to all artists residing on the Colorado Plateau and Yavapai County. Exhibiting Members are entitled to be included as exhibitors in ART35N studio tours, exhibitions and related programs. Each of these programs / events have their own application process and fees and may have additional selection criteria. Work shown by Exhibiting Members can be in any media, whether it was the type of work reviewed by the jury, or not.

Exhibiting Members receive 2 full web pages for their artist statement, a photo of themselves and up to 12 photos of their work. If accepted, you will receive details on how to submit your materials for the website.

Supporting Members are artists and non-artists who have not been juried in as Exhibiting Members. Supporting Members enjoy the same benefits as Exhibiting Members aside from their ability to show their work in exhibitions and studio tours. The annual membership fee is \$25.

Supporting Angels are members that are exhibiting artists who do not plan on participating in the yearly tour and exhibit, but want to show their continued support for ART35N with contributions of \$25 plus.
