Art35°North is a is an organization dedicated to supporting the visual arts in the region of latitude 35° North and promoting Collaboration, Conversation, Community and Creativity among artists, art supporters, art collectors and the communities of this region. ART35N encourages involvement by artists in all types of media and by non-artists seeking to support local art. Members of ART35N are eligible to participate in workshops, classes, critiques, and other related programs.

## Membership Categories

Exhibiting Member: A lifetime designation that requires artist being juried in order to participate in Studio Tours and all other benefits. Annual dues: \$50.00. Artists must live in the Colorado Plateau or Yavapai County. Additional fees will be required for Studio Tours and some of the other educational events. Any type of artistic media is acceptable.

Artists not accepted by the jurying process to be Exhibiting Members automatically receive Supporting Member status for their \$25.00 jury fee.

Supporting Members: For emerging artists, collectors, and supporters to receive access to all educational opportunities of Art35N. Annual dues: \$25.00

Friends of Art 35: Supporting members can join membership at any time with contributions of \$25 plus.

## IMPORTANT: CRITERIA FOR JURYING PROCESS:

1. It's important to choose only one media for jurying. (Even though you may be proficient in several.) Jurors will be judging on consistency in quality and command of the media.
2. High quality photographs are critical to the jurying process; these will be the only way the jury will be able to see your work.

Up to **two (2)** images may be submitted of each work. **Digital images should be a minimum size of 800 x 1024 pixels, saved at 72 dpi (or greater), in JPEG format.** This is for viewing by jurors on a digital device. Higher resolution images (5 x 7 inches at 300 dpi) will be required for marketing purposes if a member participates in an exhibition or studio tour.
